With reference to your clarification mail dated 03/09/2021, we Gramgeeta Mahavidyalaya, Chimur like to submit the responses to clarification sought for IIQA submission.

1. Please refer latest format of self-declaration from NAAC website.
2. The details of the programmes mention in IIQA is not matching with the latest affiliation letter issued by University as well as programmes displayed on institutional website. You may refer the definition of programme from manual(glossary) of NAAC as well as SOP.

Response:

- As per your clarification Point No. 1, we downloaded the latest format of self-declaration from NAAC website.
- As per your clarification Point No. 2, we prepared the self-declaration according to the NAAC glossary of programme and university affiliation letter.
- As per our affiliation of University, B.Sc. having 8 Optional subjects with 2 Compulsory subjects (Compulsory English & Marathi only for First Year students). From this optional 8 subjects we prepare 5 groups, each group having 3 subjects. As per NAAC SOP i.e., B.Sc. (Chemistry, Mathematics, Physics) as one programme and likewise. So we have considered as 5 programme for B.Sc.
- As per the University affiliation for B.A. there are 8 optional subject with 2 compulsory subjects. From these 8 optional subjects students can choose any 3 subject for B.A. and we are considering BA as a 1 programme. ***Please consider the 5 programme for B.Sc., 1 programme for B.A. and 1 programme for B.Com.***
- We are running Skill based certificate courses on institution level and they are not approved by University till now but we are planned to propose these courses for approval in upcoming academic session.
- ***So we are doubtful about their consideration and hence we are removing the certificate courses from self-declaration format as well as IIQA.***




